All funeral directors are legally required to publish this Price List for a standard set of products and services to help you think through your options and make choices and to let you compare prices between different funeral directors.

AN ATTENDED FUNERAL

(Funeral Director's charges only) **£2350.00**

This is a funeral where family and friends can have a ceremony, event, or service for the deceased person at the same time as their burial or cremation. This is a total amount of the information below, which can vary should you wish to purchase a package.

Taking care of all necessary legal and administrative arrangements. **£750.00**

Collecting and transporting the deceased person before the funeral in an appropriate vehicle. **£320.00**

The deceased person will be kept at the funeral director's branch premises.

Care of the deceased person. **£350.00**

Care of the deceased person before and up to the funeral in appropriate facilities.

Providing a suitable coffin for burial or cremation – this will be made of Oak Veneer. **£350.00**

The price of our coffins start at £200.00 and vary according to your choice. (This may also vary within a package.)

Viewing of the deceased person. **Free of Charge**

Family and friends who wish to view the deceased may do so by appointment within our business hours.

At a date/time agreed with the funeral director, the deceased person will be taken to your chosen cemetery /crematorium (within a 25-mile radius of the branch premises) in a hearse. **£580.00**

Carriage or other choice of vehicle. **£POA**

AN UNATTENDED FUNERAL

This is a funeral where family and friends choose to have a ceremony, event or service at a later date and not at the same time as their burial or cremation.

This is called a Direct Cremation and there are no mourners in attendance.

Burial charges (funeral director's charges only). **£1574.00***

Cremation (funeral director's charges plus Cremation fee). **£1349.00***

**Charges subject to inflation.*

FEES YOU MUST PAY

For an Attended or Unattended burial funeral, the **burial fee**.¹

In this local area, the typical cost of the burial fee for local residents is: **£1495.00 - £1600.00**

For a new grave, you will also need to pay for the plot; for an existing grave with a memorial in place, you may need to pay a removal/replacement fee. In addition, the cemetery may charge a number of other fees.

For an Attended cremation funeral, the cremation fee.²
In this local area, the typical cost of a cremation for local residents is: **£750.00-£1320.00**

¹ This fee (which is sometimes called the interment fee) is the charge made for digging and closing a new grave, or for reopening and closing an existing grave.

² In England, Wales and Northern Ireland, you will usually need to pay doctors' fees as well. This is the charge for two doctors to sign the Medical Certificates for Cremation.
